Introduction

SHABD, an acronym for Shared Audio-Visuals for Broadcast and Dissemination, is a news service launched by Prasar Bharati to support the daily news needs of the Indian media industry. Prasar Bharati is India's public broadcaster, which has Doordarshan and Akashvani operating under its aegis.

SHABD leverages on the expansive reporter network of Akashvani and Doordarshan to produce its news. The news is gathered from across the country, and is made available to the users from Indian news and media organisations registered for the service. Currently the news is offered in most Indian languages, in more than 24 news categories, and in formats including video, audio, text and photo.

The users can use and re-distribute the SHABD content under their organisation logo and signature. The content can be used as is, or as part of the users' news package. SHABD seeks no credit for it. However, some conditions do apply.

The service is free for use until September 2024.

Prasar Bharati is an autonomous body created by an act of Parliament in 1990. It came into effect in 1997. Read act (https://prasarbharati.gov.in/prasar-bharati-act/)

Terms and conditions

By signing up for the SHABD service, you, as a news and media organisation, agree to the following terms and conditions.

Registration: *(Not for the initial launch - During initial launch the subscribers will be getting a mail where they are not required to register and can directly get to the page); Later phase when New user is being added - Registration steps will follow.

Interested news media organisations would have to sign up for the service

- The sign up would entail registering for the service by filling up a form on the website, and agreeing to the listed terms of use.
- At sign up, the registering organisation would have to list the properties or channels on which it intends to use the content
- Sister concerns or partner organisations of the registering company would have to register separately for the service
- The registering organisation would, however, be free to share or forward web links or urls of the content it has downloaded and published, with credible retailers (administrators of WhatsApp, Telegram, Facebook, Twitter (X), LinkedIN closed groups) who may not expressly be media organisations themselves. Such content must, however, contain the said organisation's signature in the form of logo or watermark

Content Sharing:

- You are free to re-distribute or retail the content taken from SHABD to your viewers and readers through any of your properties that you have registered with us.
- Such content need not be credited to SHABD.
- Such content may also carry your organization's signature in the form of a logo.

Method of content dissemination by PBSF i.e method of access to registered users :

The Shared feed website will the vehicle for content dissemination.

Exceptions and Prohibitions:

- The registered companies are barred from editing and changing the context in which content has been produced and served to them.
- They are also barred from combining the content or using it in conjunction with news stories, features, analysis, interviews or discussion programs in a way that the context of the content is twisted or altered.
- They are also prohibited from using the content in whole or part to troll, defame, malign any person or organization.
- Also, using any part of the content with the intent to do mischief, commit fraud, deride the country and its institutions, or to create a law and order situation is prohibited.
- Use of morphing and voice cloning technologies over the content is prohibited
- Misquoting (or misrepresentation) of the content, in whole or in part, is barred.
- The registered companies would be responsible for any violations, and would have to face prosecution under applicable laws. Violators would also be stripped of their service rights.
- The registered companies would, however, not be held responsible for violation committed by groups or organisations who have received the content as forwards.

Essential:

- All content would be date and time stamped. It would be a violation to remove or mask it.
- Modifications to the materials provided by use of Artificial Intelligence (AI) tools/software's are strictly prohibited.

The user of material will be solely liable for any to modifications done to the material provided on the website. Prasar Bharati assumes no liability for any mistakes, misstatements, defamation, omissions, falsehood, obscenity, or profanity in the statements, opinions, representations or any other form of Content on the Website due to such use of such content after mofifications to change the context of the materials provided.
